At Sanctuary Supported Living we provide supported housing, move-on accommodation, CQC registered services and floating support to help people across England on their pathways for independence.

We specialise in services for young people, homeless families and individuals, people with physical disabilities, learning disabilities and people with mental health needs.



Accommodation



15 fully-furnished en-suite bedrooms in a purpose-remodelled, wheelchair-accessible building.



Within walking distance of the town centre, with shops, leisure facilities and public transport connections.



Communal areas

Large lounge and dining area, activities room, laundry room, bathroom with assisted bath and hoist, and a garden overlooking a courtyard.



Free Wi-Fi in communal areas. Integrated emergency pull cord alarm system throughout and personal pendant alarm available.



Staff office on-site and a secure door access system to help residents feel safe.

Care and Support

Everyone is supported to achieve greater independence. Staff draw up a personalised care and support plan with residents using the Life Star model. We provide 24-hour residential care and support, including personal care, depending on individual needs.

Our highly-trained staff are on-site 24 hours a day, seven days a week, giving residents peace of mind that support is always on-hand, and a bespoke nurse call system is installed throughout to provide emergency support when needed.

Residents can purchase assistive technology to further promote their independence.

Tailored care, support and assistance includes:

- Managing personal care and medication
- Socialising and community involvement
- Positive behaviour management
