All rooms in the shared house are let on a licence agreement and all flats are let on an assured shorthold tenancy.

Support

Staff draw up a personalised support plan with residents using the Recovery Star model to help them successfully maintain their tenancies and taking control of their own lives so they can move on to live independently.

Our highly-trained staff are on-site 24 hours a day, seven days a week, which includes an overnight concierge service. CCTV is in operation in all communal areas of the site and there is an out-of-hours telephone service, should residents require any further support.

Tailored support, advice and assistance includes:

- > Maintaining a tenancy, managing rent
- > Managing finances (budgeting and benefits)
- > Dealing with correspondence
- Daily living skills
- > Accessing education, training and employment
- Planning a successful move-on
- > Signposting and accessing other services
- Building confidence, resilience and self-esteem
- Managing mental health needs
- Managing rent and arrears

How to apply and eligibility

We do not accept direct applications. To apply, referrals must be made through Lancashire County Council.

All support needs will be assessed before an application is accepted.

To be eligible for a place at Wyngarth Court, applicants must:

- Be aged 18 and over
- > Have a mental health need
- > Require a minimum of 15 hours of care per week

We have developed strong relationships with the local authority and other local agencies to make sure we offer the best possible support.
