At Sanctuary Supported Living we provide supported housing, move-on accommodation, CQC registered services and floating support to help people across England on their pathways for independence.

We specialise in services for young people, homeless families and individuals, people with physical disabilities, learning disabilities and people with mental health needs.

Accommodation



Accommodation type

Nine furnished studio flats and a fully-furnished one-bedroom flat, spread across two floors. Accessible kitchens and bathrooms are available for wheelchair users.



Free Wi-Fi in communal areas. We can provide assistive technology for extra safety and reassurance, which can be purchased at additional cost.



Location

Edmonton, between Pymmes Park and Craig Park. Close to shops, supermarkets and cafés, as well as bus, train and tube connections.



Communal areas

A lounge, laundry room and shared level-access garden.



Safety and security

Staff office on-site, CCTV and a secure door access system to ensure residents feel safe and secure.



Rental agreement type

All flats are let on an assured shorthold tenancy agreement.

Care and support

Staff draw up a personalised care and support plan with residents using the Mental Health Recovery Star model. We can provide 24-hour care and support, including personal care, depending on individual needs.

Our highly-trained staff are on-site 24 hours a day, seven days a week, giving residents peace of mind that support is always on-hand. There is an overnight concierge service seven days a week and an out-of-hours telephone service, should residents require any further support. Residents can also purchase additional telecare technology to further promote their independence.

Tailored support, advice and assistance includes:

- Daily living skills
- Maintaining a tenancy
- Managing personal care and medication
- Manging finances (budgeting and benefits)
- Cooking, cleaning and shopping
- Building positive relationships
- Developing hobbies and interests
- Maintaining health, safety and security
- Planning a successful move-on

Signposting and accessing other services

How to apply and eligibility

We accept referrals from Enfield Mental Health Services.

All care and support needs will be assessed before an application is accepted.

To be eligible for a place at Stepping Stone Court applicants must:

- > Be aged 18 or over
- > Have a mental health need
- > Require 24-hour support

We also provide follow-on support after residents move into their own independent accommodation.
